## Minutes

1. Call to Order: Greg Ransom

2. Pledge of Allegiance: Greg Ransom

At this time Greg Ransom reported to the Athletic Council that the Orange County Superintendant Representative, Sean Michel resigned immediately. Greg thanked Minisink Valley Superintendant Brian Monahan for stepping up to be Orange County Superintendant Representative.
