Executive Director Greg Ransom will be meeting with the MHAL and OCIAA to review how to be more diligent with the Sport Handbooks and NYSPHSAA Rule and Regulations.

Robert Zayas NYSPHSAA Executive Director, requested information from Sections regarding:

- a. Status of Spring State Championship
 - Section IX is in favor of cancelling the Spring 2020 NYSPHSAA Championships on Monday, April 27, 2020.
 - 2. Continue to postpone Spring 2020 State Championships. Section IX is not in favor of postponing. Status of Spring regular season
 - 1. Section IX is not in favor of cancelling the Spring regular season on Monday, April 27, 2020.
 - Section IX is in favor of cancelling the regular season if schools are not opened by May 18, 2020.
 If NYS Pause is extended beyond May 18, 2020 Section IX is in favor of cancelling the regular season.

There was a lot of discussion regarding what Governor Cuomo will do in the near future on extending the date to open New York State. There are so many issues to review such as Number of Practices to restart, what constitutes a Spring Season and what will the Fall Season look like. The next Section IX Meeting Date is Tuesday, May 12, 2020 some of these questions will be answered.
