Section IX Athletic Council Meeting Meeting Minutes Tuesday, March 14, 2023

- 1. Call to Order Greg Ransom All members present except Jason Semo and Marco Lanzoni.
- 2. Review of Meeting Materials Jim Osborne, Secretary All materials were sent to the Athletic Council and posted on the Section IX website.
- 3. Approval of Minutes for January 4, 2023 *Motion to approve by Ray Castellani, seconded by Brian Monahan. All in favor. Motion carried.*
- 4. Financial Report Linda Trapani, Treasurer *Motion to approve by Brian Monahan, seconded by Tim Bult. All in favor. Motion carried.*Greg Ransom discussed invoices that are still outstanding for the Fall of 2022. Robbie Greene suggested an escalator be placed on the invoices not paid. The classification committee met and the following decisions were made:

**Boys Soccer** will remain in **Class C** for the upcoming 2023-2024 season. While Mount Academy did not win a sectional title this year, they were very competitive with an 11-4 overall record in the first year as a Class C team.

Boys Cross Country will drop down from Class B to Class C for the upcoming 2023–2024 season. Even though Mount Academy has won the Section Championship in 2 of the last 3 seasons that had championships, the state level competitiveness has dropped each of those years which is why moving Mount Academy from Class B to Class C is justified.

**Girls Soccer** will move from Class D to **Class C** for the upcoming 2023-2024 season. Mount Academy has won the last 3 Section Championships. Mount Academy has also won the last two New York State Championships in Class D which is why moving them up to a Class C is justified.

**Girls Volleyball** will move from Class D to **Class C** for the upcoming 2023-2024 season. Mount Academy has won the last 4 Section Championships. Mount Academy has placed in the top 3 at the New York State Championships over the past 4 seasons including 2 NYS Championships that last two years. This is why moving them up to Class C is justified.
