**TEAM EXHIBITION INFORMATION**

***Registration fee: \$25***

- **Cheerleaders:** No Uniforms are to be worn. Cheerleaders should wear shorts and t-shirts. Team logos are ok. This is not a competition
- **Schedule:** Exhibition and warm-up times will be distributed approximately 1 week prior to the exhibition. Teams will be given about 10 minutes to warm up. (stretching, run through, and tumbling) Immediately after warm up, they will perform in front of the judging panel.
- **Time Slots:** Please select your top 3 time slots in order of preference. We will do our best to accommodate every team's request.
- **Performance:** Do as much or as little of your routine as you would like. Inform the judges ahead of time if you need timing done to make sure you are meeting requirements. This is a closed event and no spectators are allowed!
- **Music:** Bring iPod/cellphone/cd. It is the coach's responsibility to check his/her music in the sound system.
- **Score Sheets:** The judges will score all parts of the routine that you perform. They will time all required sections. Following your performance, your team will exit the gym. After the judge's complete their scoring they will speak with the coach and give feedback on the scoring. Judges cannot give choreography advice but the coach can ask questions. For example, "If we add this skill will it increase our score?" We will have at least 2 panels of judges so as one panel completes their scoring and speaks with the coaches; the other panel is judging the next team.
- **JV Teams:** We will inform all coaches if there are available slots for their JV teams. In order for a JV team to be able to participate, their Varsity has to have registered.
