



# MIKE DeCAPUA SCHOLARSHIP APPLICATION

If our fundraising efforts are successful this year, Friends of Section 9 Wrestling should have accumulated enough money to be able to award scholarships to some of our top senior athletes this year. The scholarships will be in the name of former Valley Central Coach Mike DeCapua who was a victim of cancer in 2003. Mike was a former Section 9 Champion for New Paltz, wrestled in college for Division One schools Clarion and Syracuse University, and then came back to coach in Orange County. Our goal is to provide five-\$ 300 scholarships but the number of scholarships awarded and the amount of each one may have to be altered if our fundraising efforts do not meet our estimated goals.

The following application must be completed if you would like to apply for the scholarship. A point system will be applied to each application to determine a ranking of the applicants. The top applicants will receive the scholarships. Coach DeCapua strongly encouraged his wrestlers to continue their careers by wrestling in college. As was his wish, to be eligible to apply for the scholarship you must be a senior and you must plan on continuing your wrestling career in college. If you are selected as a scholarship winner, you will not receive your award until the end of your first season, after you produce proof of completion of the season. Award winners will be announced at the annual Friends of Section 9 Banquet in March.
