- 8 lane track, curbed preferred
- 2 Long Jump/Triple Jump pits
- Pole Vault area
- 2 Shot/Discuss cages
- Steeplechase 2000/3000 adjustable barriers, water pits
- Lighted track AND field areas
- Press Box with a PA System
- Adequate restroom facilities
- Fenced track/field areas for safety/security purposes
- Electrical system at the Finish Line for FAT timing
- Adequate parking for busses, officials and spectators
- Adequate changing/shower area for both Boys and Girls
- Covered clerking area
- Covered Athletic Trainer area
- Covered Awards area
- Water availability
- Proper equipment: 100M Hurdles, HJ pit with standards, PV pit with standards, crossbars, rakes/brooms/squeegees
- 3 tables, 6 chairs at the Finish Line for Meet Management/FAT crew
- Buckets of water or Sandbags if infield is artificial turf. Tents need to be weighted down or staked into the ground.
